16.00 Memorial Site Paver Procedures

16.01 Member pays for the ability to select the inscription on a paver and completes paver form.

16.02 The complete cost of all pavers, as set by the Fund, will be incurred by the designator of the inscription.

16.03 Installations and placement of all pavers will be determined by the Fund.

16.04 Pavers are exclusively Fund property

16.05 Inscriptions outside of the following:

- Member's name (including nicknames)
- Member's position held/department
- Member's entrance/exit date
- Member's date of birth/date of death
- Member's class/station
- "In honor of" dedications as long as it honors the Member must be approved by the Memorial Committee.

16.06 The information on the paver must be firefighter-related and no advertising is allowed.

16.07 Prior to installation, the member is allowed up to 40 characters of inscription per paver without additional cost. However, members will be charged extra for any extra character(s) beyond 40. Once paver is installed, an extra fee will be incurred by the member for any additional engraving.
